Spring Semester 2010 Refund Schedule	
Class days are counted by excluding Saturdays, Sundays, and Holidays	
Before the first day of classes (Before January 7, 2010)	100% Refund (less \$20.00 enrollment cancellation fee)
1st through 5th day (January 11, 2010 - January 15, 2010)	90% Refund
6th through 10th day (January 16, 2010 - January 25, 2010)	70% Refund
11th through 25th day (January 26, 2010 - February 15, 2010)	50% Refund
After 25th day of classes (after February 15, 2010)	No Refund

Fees subject to refund include the Educational Fee, Information Technology Fee, Supplemental Fees, Health Service Fee, Activity/Facility Fees and any instructional related fees which may be assessed. Deductions may be made for any financial obligation due the University.

Students who have registered for credit courses and whose registration is subsequently canceled, who withdraw from the University or reduce their course load, will, subject to certain exceptions, receive a refund of fees in accordance with the above schedule.
