*Educational & Information Technology Fees are assessed on a per credit hour basis. Students enrolling for more than 18 hours will be assessed accordingly.

An additional Supplemental Fee will apply for the following and will be charged per credit hour:

Engineering Supplemental Fee of \$54.50 per credit hour will be charged to all students enrolled in engineering courses, except for courses offered by the Department of Geology & Geophysics. Co-listed courses are subject to the Engineering Supplemental Fee.

Courses and Science Supplemental Fee of \$54.50 per credit hour will be charged to all students enrolled in Computer Science, Biological Sciences, Chemistry, Students in Geology, and Geophysics courses. Co-listed courses are subject to the Science Supplemental Fee.

A maximum Science Supplemental Fee for Physics of \$27.30 per credit hour will be charged to all students enrolled in Physics courses. Co-listed courses are subject to the Science Supplemental Fee for Physics.

Fees subject Business, IS&T, and M&IS Course Fee of \$27.30 per credit hour will be charged to all students enrolled in Business, IS&T, and M&IS courses. Fees and any Co-listed courses are subject to the Business Supplemental Fee.

Students who have registered for credit courses and whose registration is subsequently canceled, who withdraw from the University or reduce their course load, will, subject to certain exceptions, receive a refund of fees in accordance with the above schedule.

The Midwest Student Exchange Program (MSEP) was established by the Midwestern Higher Education Commission to increase interstate educational opportunities for students in its member states.

The program enables residents of Kansas, Michigan, Minnesota, Nebraska, North Dakota and Wisconsin to enroll at Missouri S&T at the following rates.
